

CONDITIONS OF RELEASE

- 1. The defendant is required to attend any and all district, municipal, county, or common pleas proceedings related to the bail bond posted.
- 2. When the defendant is released from any jail or correctional facility, he or she is required to report to Lehigh Valley Bail within 24 hours of his or her release for an interview and photograph.
- 3. If the defendant misses a court appearance, you must notify Lehigh Valley Bail at once to dissolve the warrant and get a new court date.
- 4. The defendant is required to CHECK-IN once per week in person at the following location:

445 W. Linden Street, 1st Floor Allentown, PA 18102

- 5. If it is physically impossible to CHECK-IN in person then the defendant may call 484-223-0269 to CHECK-IN by telephone once per week.
- 6. The defendant is required to notify Lehigh Valley Bail of all new court appearance dates. The defendant is required to submit a copy of court date notices to Leigh Valley Bonds.
- 7. The defendant and indemnitor(s) are required to notify Lehigh Valley Bail of any and all changes in address and telephone.
- 8. The defendant is required to notify Lehigh Valley Bail of his or her current attorney.
- 9. All defendants or their indemnitor(s) must immediately notify Lehigh Valley Bail if the defendant is re-incarcerated for any reason.
- 10. The Defendant and indemnitor(s) are required to pay any outstanding premium balances in accordance with the terms established in the promissory note.

Bail Revocation Conditions

Failure to comply with any above conditions of release could be grounds to revoke the bail bond posted, rearrest the defendant and surrender the defendant to proper authorities.

In the event of your re-arrest or surrender by Lehigh Valley Bail or any other authority, as a result of a bail revocation or forfeiture, the defendant and all indemnitor(s) shall be held joint and severally responsible for any fees or costs arising from such an arrest.

Bail Exoneration Conditions

The defendant follows all conditions of bail and attends all required court appearances until conclusion of the case. Or, if the defendant's bail had previously forfeited, the court ordered an exoneration to the surety as a result of Lehigh Valley Bail efforts or its counsel. The defendant and/or indemnitor(s) would be responsible for any costs.

Collateral cannot be returned to the defendant or the indemnitor(s) until the appropriate court provides written proof of discharge or exoneration of all of the bail bonds posted.
